#### 1. Executive Summary

Myint & Associates Offshore Supply Base Ltd (M&AOSB) is planning to develop an Offshore Supply Base (OSB) near Nga Yoke Kaung Bay in Ayeyarwady Region, which is located approximately 40 km south of the town of Ngwe Saung. The project includes the construction of an island jetty head with deck, a causeway (1.2 ha) and an onshore facility (12.12 ha). The supply base will consist of short-term & long-term storage facilities, custom inspection area, main office area, accommodation area and other utilities required for the support of offshore Oil & Gas Logistics. Overall the area could be expended to up to 50 ha onshore in phase 2.

Since 2016, M&AOSB began socialization of its proposed project activities with the members of the local community by hosting public meetings and regular engagements. M&AOSB established its Corporate Social Responsibility (CSR) program in 2017. In terms of environmental management, M&AOSB has completed its Environmental Impact Assessment (EIA) processes and Environmental Compliance Certificate (ECC) was awarded on 24 April 2019 by the Environmental Conservation Department (ECD) under Ministry of Natural Resources and Environmental Conservation (MONREC).

#### 1.1 Key Highlights (April to September 2019)

- After obtaining the ECC on 24 April 2019, public disclosure workshops were conducted in Pathein and Nanttharpu Village Tract from 25 to 27 June 2019. Latest project information, EIA process, findings, and mitigation measures were disclosed.
- Design and Build Contractor selection for the M&AOSB project is in its final stages. Environmental Management Plans (EMPs) and Environmental Monitoring Plans (EMoPs) are in preparation and these will be finalized in coordination with the Design and Build Contractor and submitted to ECD prior to the start of construction.
- Other requirements, including detailed information about the project such as the final layout plan with facilities lists will be included in the subsequent report.
- In accordance with clause D6 of ECC, the environmental monitoring reports will be prepared and submitted to ECD every 6 months during the project.
- As part of social management, CSR work program for the fiscal year 2019-2020 was rolled out in May 2019, where 14 skills trainings are planned for the year. From April to September 2019, 8 trainings had been completed including masonry, carpentry, welding, and excavator operator trainings.
   Total (195) trainees completed their respective trainings.



#### 2. Introduction

Periodic environmental monitoring will be conducted by M&AOSB. The environmental inspection and compliance monitoring program will be implemented under the direction and guidance of Ministry of Natural Resources and Environmental Conservation (MONREC).

The Construction Monitoring Report will be prepared in accordance with clause D-6 of the ECC. Summary of the monitoring activities will be included in the report and M&AOSB will report to the Ministry with the frequency of not less than six (6) months. This Construction Monitoring Report shall include:

- i) Documentation of compliance with all conditions of this ECC, in particular on the commitments made in Table 8.2 of the EIA report.
- ii) Progress made to date on implementation of EMPs against the submitted implementation schedule
- iii) Difficulties encountered in implementing EMPs and recommendations for remedying difficulties and steps to prevent or avoid similar future difficulties.
- iv) Number and type of non-compliances with EMPs and proposed remedial measures and timelines for completion of remediation
- v) Summary of self-monitoring reports including explanatory remarks
- vi) Summary of accidents or incidents relating to the occupational and community health and safety
- vii) Summary of complaints and grievances redress mechanism (GRM)



#### 3. Roles and Responsibilities

**Project Proponent (M&AOSB) –** shall monitor all construction activities and carry out random site inspection under the guidance and supervision of Project Management Consultancy (PMC) in strict compliance with the conditions of the ECC and liaise with the Ministry. Project proponent is accountable for the timely submission of Environmental Monitoring Reports to MONREC.


**Design and Build Contractor(s)** – shall implement EMPs s defined in the ESIA and ECC and carry out continuous risk assessment and environmental controls on all construction activities. It is their duty to enforce all sub-contractors to follow prescribed environmental control measures. Design and Build Contractor is accountable for the implementation of EMPs and other obligations from the EIA and ECC.

**Environmental Monitoring Services –** shall undertake monitoring of all environmental and social parameters prescribed in the EIA. Environmental Monitoring Services shall prepare a report of findings with analysis of the project's environmental and social conditions. Environmental Monitoring Services will be performed by either a third party Contractor, M&AOSB in-house resources or a combination of both.

Note: Since contractor selection is still in progress, detailed information about each party will be described in the next report.



#### Institutional Framework of Environmental Monitoring Reporting



This institutional framework of environmental monitoring report is for the construction phase only. The operational phase will be prepared upon completion of construction phase and before commencement of operations.



#### 4. Current Project Environment

There was no construction activities during April 2019 to September 2019. M&AOSB is in the process of evaluating proposals to select a Design and Build Contractor.

At the project site, there is currently a temporary camp (consisted of one twostory building and a shelter), a ground water well which existed before the temporary camp was erected and now supplies the camp, water reservoir tanks, toilet and septic tanks, and a general waste collection area. The temporary camp is powered by solar energy and a generator. At the moment, there is no national grid connection in Nanttharpu Village Tract.



#### 5. Project Progress

#### 5.1 Project Progress Prior to ECC

#### **Technical Surveys**

Several investigations and surveys were conducted in designing the onshore and offshore facilities of the proposed supply base. In 2017, Bathymetric Survey were conducted from 23 to 29 July 2017 to measure the ocean depth through sounding and Metocean Survey from 21 July to 24 August 2017 by Blue Delta Yangon Co., Ltd. to study the conditions of wind, wave and climate. The meteorological studies including the wind speed, wind direction, occurrence and strength of typhoons, hurricanes and other natural disasters and oceanography studies including the historical and seasonal sea level changes, tides, and wave heights were undertaken.

Offshore Soil Investigation (Phase 1) and onshore soil investigations, and Topographic survey were also conducted from 25 August to 25 September 2017 by Blue Delta Yangon Co., Ltd and Fukken Myanmar Co., Ltd., respectively. All surveys were carried out for the design of onshore and offshore (jetty) facilities.

A series of public disclosures with Township and Town General Administration Departments, Town and Village Authority and Administrators, Local Fishermen and Civil Society Organizations (CSOs) in Pathein, Nga Yoke Kaung and Nanttharpu were conducted prior to the technical surveys, communicating the context of the investigation activities and addressing the possible concerns and impacts from the community. About 92 stakeholders were consulted in total of 4 sessions which were conducted from 10 to 12 July 2017.

Offshore Soil Investigation (Phase 2) was conducted from 08 November 2018 to 16 January 2019 to acquire comprehensive information related to the soil at the proposed jetty construction area. Blue Delta Yangon Co., Ltd. was selected as the contractor for soil investigation surveys and drilling of additional boreholes.

A series of public consultations were conducted prior to the mobilization of survey equipment and contractor personnel to communicate to local stakeholders about the upcoming surveys and provide project progress updates as follows:

#### **Electrical Transmission Line Survey**

M&AOSB has began surveys on possible options to connect to the nearest national electrical grid at the Nga Yoke Kaung Town Sub-station. This is in an investigation phase and detailed information about the outcome of the investigation will be included in the subsequent report.

#### 5.2 Progress of Design and Build Contractor Selection

M&AOSB started the tender for the Design & Build contract for the proposed offshore supply base on 18 January 2019. M&AOSB is in the process of evaluating proposals and final negotiations with the preferred bidders. After contract award, M&AOSB and Design & Build contractor will develop and submit environmental management plans.

#### 5.3 Progress of Environmental Monitoring Services Selection

A third party Environmental Monitoring Services selection is in progress. Once the Design & Build contract is award, the Environmental Monitoring Services will also be awarded and a pre-construction survey will be performed.

#### **5.4 Operational Grievance Mechanism**

M&AOSB rolled out an operational grievance mechanism (OGM) at the project area since August 2017. A field coordinator has been appointed to liaise with the stakeholders to resolve the received concerns in a timely manner. In order to promote awareness, OGM information boards has been set up at strategic locations such as intersections with high foot traffic in Nga Yoke Kaung Town, Kyway Chaing and Nanttharpu Village Tracts. Locations of the information boards are illustrated in the Annex

At the time of the preparation of this report, there has been 7 grievances raised and resolved. The summary of OGM cases is provided in Annex.

M&AOSB is in the pre-construction phase, and the M&AOSB operational grievance mechanism will be contextualized for the construction phase in compliance with clauses F-1, F-2, F-3, F-4, F-5 and F-6 of the ECC. This will be submitted together with other management plans in the next report.



#### 6. Environmental Management

The M&AOSB project is in its pre-construction phase, and the Design and Build Contractor selection is in progress in parallel with the selection of Environmental Monitoring Services. During the period covered by this report, there was no activity at the project location except ithe implementation of CSR initiatives.

#### 6.1 Environmental Management Plans

Prior to the construction phase, M&AOSB and the Design & Build Contractor will jointly develop the following (7) sub-management plans as per ECC Clause C-10.

- Emergency Response Plan
- Traffic Management Plan
- Waste Management Plan
- Livelihood Restoration and Compensation Plan
- Biodiversity Management Plan
- Water Quality and Sediment Management Plan
- Occupational Health and Safety Plan

In addition to the above-mentioned (7) plans, oil spill contingency plan, disposal plan for dredging materials, decommissioning plan and final layout with facilities lists for each phase will be prepared together with the Design and Build Contractor in accordance with ECC clauses C-7, C-5, C-11 and C-6 respectively.

The above-mentioned plans will be prepared according to the below:

#### Step (1)

The Design and Build Contractor will lead the development of the submanagement plans with the collaboration of M&AOSB. Once finalized, these sub-management plans will be submitted to ECD.

#### Step (2)

The sub-management plans will be implemented by both the Design and Build Contractor and the M&AOSB as described in the sub-management plans.

#### Step (3)

The implementation of the sub-management plans will be continuously monitored to ensure compliance with the plans. The relevant information about the sub-management plans will be reported to ECD as part of Environmental Monitoring Reports.



#### 7. Social Management

#### 7.1 Approach

Since 2016, M&AOSB established its Corporate Social Responsibility Program in the project area to initiate relationship building and build trust with primary project stakeholders. In order to achieve this, M&AOSB deploys a muti-pronged approach as follows:

- Robust stakeholder engagement and consultations to invite participation in every stage of the project and to effectively and transparently communicate about the proposed project
- Strategic and impactful community investments which create shared value for the business and society
- Corporate sponsorships and philanthropy
- Employee volunteerism

#### 7.2 Community Investment

M&AOSB CSR program covers Nga Yoke Kaung Town, Nanttharpu Village Tract and Kyway Chaing Village Tract. Currently, M&AOSB partners with a total of 8 community-based volunteers to conduct community engagement and investments.


#### National Skills Standard Authority (NSSA) Level-1 Tests

After completion of the construction skills trainings, M&AOSB coordinated and arranged for the interested candidates from welding, carpentry, and masonry trainings to sit for their respective National Skills Standard Authority (NSSA) Level-1 tests in Yangon.

The NSSA exam included the theory and practical assessments. A total of 7 welding trainees, 20 masonry trainees, and 20 carpentry trainees passed the NSSA Level-1 exams. NSSA certificates are recognized within the ASEAN region and this increases access to job opportunities not limited to the M&AOSB project.

#### 7.3 Stakeholder Engagement and Project Information Disclosure

In order to ensure project transparency, M&AOSB engaged key stakeholders at the national, state/region, and township/village tract levels.





#### Stakeholder Engagement (April 2019)

Soon after receiving the ECC on 24 April 2019, an engagement trip to Pathein from 29 April to 30 April. Ayeyarwady Region Minister of Electricity, Energy, Industry, Roads and Transport, MP (Ayeyarwady Region Parliament), and members of MATA (Ayeyarwady) were engaged and shared the latest updates about the ECC.



#### Stakeholder Engagement (May 2019)

During the month of May, in accordance with the EIA procedure, M&AOSB disclosed and distributed its approved EIA reports (Hard Copies) to the ECD (Nay Pyi Taw), ECD (Pathein), General Affairs Department (Pathein), General Affairs Department (Nga Yoke Kaung), Fisheries Department (Pathein), Fisheries Department (Ngaputaw), Fisheries Department (Nga Yoke Kaung). Executive summaries of the EIA report were distributed to the Village Elders from Nga Yoke Kaung (Ward 1 and 2), Nanttharpu and Kyway Chaing in the third week of May 2019.

Apart from distributing hard copies, the ECC and the approved EIA report were uploaded on the M&AOSB's website together with the report's executive summaries.

M&AOSB held a meeting with the Ayeyarwady Region Minister of Electricity, Energy, Industry, Roads and Transport and members of the Ayeyarwady Investment Committee (AyaIC) on 22<sup>nd</sup> May 2019 and presented the project activities, future plan and upcoming ECC disclosure trip in June 2019. Another meeting was conducted with MATA (Nga Yoke Kaung) on 2<sup>nd</sup> May 2019 and discussed about the CSR program for FY 2019-2020.





#### **Stakeholder Engagement (June 2019)**

ECC disclosure workshops were organized in June 2019.

ECC disclosures were held at (3) locations from 25 to 27 June 2019. At the 25 June workshop at Pathein, the Ayeyarwady Region Minister of Electricity, Energy, Industry, Roads and Transport gave an opening speech followed by sharing the latest project information and EIA process by respective persons. Total (44) persons from Government Departments, CSOs, and other interested parties actively participated in the workshop.

On 26 June, a disclosure workshop was conducted in Nanttharpu. A total of 252 participants joined the workshop and their questions were addressed by the respective persons from the Government Department, M&AOSB, and ERM.

On 27 June, latest project information and EIA processes were presented to the Members of Parliament (Ayeyarwady Region) at the regional parliament (Pathein). This disclosure meeting was officiated by the Chairman of the Parliament. All the concerns of the members of parliaments were addressed during the disclosure.

#### 8. Conclusion






